

Terms and conditions of the “Alexa Accessibility Skills Hackathon” competition

- 1) These terms and conditions (here in after referred to as “terms”) stipulate the rules and conditions of the “Alexa Accessibility Skills Hackathon” competition taking place within the scope of the event Innovation@Amazon Online Hackathon and is an annex to the general terms and conditions of the Innovation@Amazon Online Hackathon.
- 2) The Hackathon Sponsor and promising prize within the meaning of art. 921 § 3 of the Civil Code (Journal of Laws 2017, item 459) is Amazon Development Center Poland Sp. z o.o. based at al. Grunwaldzka 472, 80-309 Gdansk, entered into the Register of Entrepreneurs maintained by the District Court for Gdańsk-Północ in Gdańsk, Commercial Division VII of the National Court Register under KRS number 0000211231, NIP 5862128060, with the share capital of PLN 452,000, which may be contacted by sending a message to the following e-mail address: innovation-hackathon@amazon.com
- 3) The task is to build an Alexa skill or its prototype that supports people with disabilities or their allies (family, friends, coworkers, caregivers) by improving their well-being and inclusion. Details of the task will be presented at the start of the competition.
- 4) Participation in the "Alexa Accessibility Skills Hackathon" Competition may be taken individually and in teams of up to five people who have started solving the competition task no earlier than at 18:00 CET on November 27, 2020 and forwarded the task for evaluation no later than at 10:00 CET on November 29, 2020. The task submitted for evaluation should include: project title, team ID, project description, snapshots, PDF presentation, demo link, pitch video. The task solutions should be submitted to the ChallengeRocket platform.
- 5) Participants related or affined to the second degree with members of the “Alexa Accessibility Skills Hackathon” competition Jury, as well as with members of the Hackathon Sponsor, are excluded from participation.
- 6) The list of prizes to be awarded as part of the Competition shall be made available at <https://innovation-amazon.com/>. The list of awards shall be updated no later than on the Competition opening day.
- 7) The list of prizes will provide details on the dates by which each prize will be paid out.
- 8) The Competition is to present the solutions to the problem - an open task. The solutions of the tasks will be evaluated by a Jury assigned to the Competition, consisting of at least three members.
- 9) The Jury will choose the winning solution based on the following criteria:
 - Idea - 30%
 - Technical aspects -30%
 - Design - 20%
 - Relation to task category - 10%
 - Wow! factor - 10%
- 10) Solutions shall be compliant with the [Amazon Developer Services Agreement](#).
- 11) Any alterations or revisions made after the statutory time is expired will not be permitted and the Jury will not consider such alterations and revisions.
- 12) Author’s proprietary copyrights to the awarded solution will not be transferred to the Competition Partner.

- 13) Jury members will be posted on Innovation@Amazon Online Hackathon website no later than on November 27, 2020
- 14) Jury and jury members' decisions are final and cannot be challenged by the participants of the competition in the course of any appeal procedure.
- 15) Participation in the competition means acceptance of all terms of the hereby Competition Rules.
- 16) The Amazon Development Center Poland Sp. z o.o. may cancel the Competition at any time without giving a reason.
